

#### TIP OF THE MONTH

### The SBA's Surety Bond Guarantee Program

For small businesses in the construction industry, one of the most significant hurdles to success in federal government contracting can be the Federal Acquisition Regulation's (FAR's) requirement to obtain <u>payment and performance bonds</u> for most federal construction projects, as well as FAR's requirement for <u>bid guarantees</u> (which contractors often provide through bonds, as well). Surety companies maintain strict financial requirements for issuing bonds, making it difficult for many small businesses to obtain bonding in the amounts required for certain federal projects.

That's where the U.S. Small Business Administration comes in. Unbeknownst to many construction contractors, the SBA operates a robust Surety Bond Guarantee (SBG) program. Under the SBG program, the SBA steps in as the guarantor of bid, performance, and payment bonds issued by sureties to qualified small businesses. The SBA doesn't directly issue the bonds. Instead, it essentially plays the role of a parent co-signing on a car loan issued to a young adult, promising to cover most of the surety's losses if the small business defaults. The bond guarantees provided by the SBA offer sureties the assurance that they're making a good investment by providing bonding to small businesses.

The SBA recently expanded the coverage of the SBG program for the first time in over a decade. Earlier this year, the SBA **announced** that it would begin providing bond guarantees on federal construction contracts of up to \$14 million—a substantial increase over the previous \$10 million limit. Furthermore, the SBG program isn't limited to federal contracts: the SBA also provides bonds for commercial contracts of up to \$9 million, up from the \$6.5 million limit in 2023.

The SBA's data demonstrates that many small businesses are successfully taking advantage of the SBG program. A <u>recent SBA report</u> indicates that during the government's 2024 Fiscal Year, which ended on September 30, the SBA guaranteed more

than 11,000 surety bonds with a total contract value of \$9.2 billion. Both figures represent all-time highs.

Who qualifies for a surety bond guarantee from SBA? <u>SBA's SBG program regulations</u> provide that a bond guarantee can be provided to a company that:

- Qualifies as a small business, including the consideration of any affiliates.
- Possesses good character. The SBA may presume a lack of good character if any owner of 20% or more, officer, or director is currently incarcerated or has engaged in fraudulent behavior.
- · Is not suspended or debarred from federal government contracting.
- Certifies that it needs bonding to bid on and/or perform a specific contract.
- Certifies that it cannot obtain the bond(s) on reasonable terms without the SBA's guarantee.

More information about the SBA's requirements can be found in <u>SBA Form 994</u>, the application form for bond guarantees.

Bonding can be a significant hurdle for small businesses looking to enter or grow in the federal contracting marketplace, but the SBA's SBG program offers an answer.
